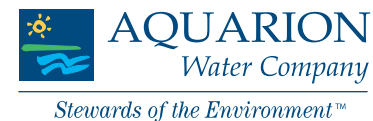

2023 Customer Assistance Program



FOR CONNECTICUT CUSTOMERS

About the Program

To assist customers in need, Aquarion Water Company of Connecticut has a Customer Assistance Program where a \$50 one-time voucher will be provided to qualified home-owners or contractual renters who are current with their water bill (bill must be in the renter's name). A total of \$50,000 has been allocated for eligible customers in Aquarion's service territory, and distributed on a first come, first serve basis, and the program will conclude at the end of the year.

Application Process

To apply for assistance, customers must provide their most recent water bill and sign the application form to the right. Send the application, recent copy of the water bill in a stamped envelope to Operation Fuel at the address provided on the application. Certain customers may be eligible for a one-time grant of up to \$250. To be considered for the one-time grant of up to \$250, you must include proof of four payments within a 12-month period and documentation of all household members and their income.

All applications must be submitted to Operation Fuel by December 31, 2023.
