NOTICE OF PUBLIC HEARING AND REQUEST FOR COMMENTS

D.P.U. 23-120 June 6, 2024

Petition of Aquarion Water Company of Massachusetts, Inc., for Authorization and Approval to Incur Long-Term Indebtedness in the Principal Amount Not to Exceed \$6,600,000, pursuant to G.L. c. 165, § 2 and G.L. c. 164, § 14.

Aquarion Water Company of Massachusetts, Inc. ("Aquarion" or "Company") supplies water to certain customers in Dover, Millbury, Oxford, Plymouth, and Sheffield, Massachusetts. On February 12, 2024, the Department of Public Utilities ("Department") approved the request of Aquarion for authorization, pursuant to G.L. c. 165, § 2 and G.L. c. 164, § 14, to incur long-term debt in an aggregate amount of \$6,600,000 to finance water treatment projects in Oxford and Millbury. Aquarion Water Company of Massachusetts, Inc., D.P.U. 23-120 (February 12, 2024).

On June 4, 2024, the Company filed a motion requesting that the Department reopen the proceeding in D.P.U. 23-120 in order to seek Department authorization to issue an additional \$2,692,76 in long-term debt to finance the Oxford and Millbury water treatment projects. Aquarion maintains that the additional financing authority is necessary because the bids it received for the construction of the Oxford and Millbury water treatment projects were \$1,460,000 and \$1,220,000, respectively, higher than the Company's original cost estimates. Accordingly, the Company requests revised Department authority under G.L. c. 165, § 2 and G.L. c. 164, § 14 to issue long-term debt in an aggregate principal amount not to exceed \$9,292,763 (i.e., \$6,600,000 approved in D.P.U. 23-120 plus an additional \$2,692,763). The Company maintains that the remaining terms of the financing approved in D.P.U. 23-120 will remain the same.

The Oxford and Millbury water treatment projects have been awarded certain beneficial funding through the Massachusetts Drinking Water State Revolving Fund ("DWSRF"). To ensure that the Company has the opportunity to access the DWSRF funds, Aquarion indicates it must execute construction contracts for the treatment projects no later than June 30, 2024. Accordingly, the Company requests that the Department approve its revised financing request no later than June 26, 2024.

The Department will conduct a public hearing on **Thursday**, **June 20**, **2024**, **beginning at 2:00 p.m**. to receive comments on the Company's revised financing request. The Department will conduct the hearings virtually using Zoom videoconferencing. Attendees can join by entering the link, https://us06web.zoom.us/j/87524214525, from a computer, smartphone, or
